

TORONTO IN-LINE SKATING CLUB – PHOTO AND MEDIA CONSENT

SUMMARY + SPIRIT OF THE PHOTOS AND MEDIA CONSENT

- **What TISC will do:** take photos and videos at TISC related events
- **Purpose of photos and videos:** online (social media, website) and print (brochures) marketing & archiving + information, administration, coaching (video analysis), and celebrating TISC culture
- **What must TISC registrants and members do:** Agree and consent in order to participate and attend practice and competitions

MUST CONSENT TO PARTICIPATE

In order to register and participate in Toronto In-Line Skating Club Related Events (including but not limited to races, practices, training, events, demonstrations, promotions, fundraisers, promotions, coaching sessions, competitions) (TRE), Photo And Media Consent (PMC) must be agreed to.

That means agreement consent to and understanding that photos, videos, and other media will be taken and produced at TRE and these may be used in print (flyers, brochures) and digital (social media, website) forums as well as for purposes of promotion, grant applications, sponsorship and marketing) as well as for administrative purposes.

COMPLETE AND SUBMIT IS CONSENT

Completing and submitting the membership application indicates acknowledgement and agreement by the registrant, if the registrant is under the age of 18, the Parent/Guardian of the registrant (each a “Party” and collectively the “Parties”) of an understanding that

PHOTO AND MEDIA WILL BE TAKEN AND PRODUCED

In order to participate in TRE, the registrant authorizes any photographs, images, video and/or audiovisual recordings of the registrant or, if the registrant is under the age of 18, both or either of the Parties, in whole or in part, individually or in conjunction with other photographs, images, video and/or audiovisual recordings,

PHOTO AND MEDIA CAN BE USED FOR VARIOUS PURPOSES

To be taken, used or displayed (including to the general public) by TISC or any of the Organizers (directors, coaches, staff, volunteers, instructors, officials) in any current or future manner and/or medium for publicity, marketing, promotion and/or educational purposes (including without limiting the generality of the foregoing, online presentations and printed material).

OWNERSHIP OF PHOTO AND MEDIA

TISC or any of the Organizers may take, own, retain, license, assign and/or use the same or any portion thereof, anytime and anywhere, in any current or future manner and/or medium;) each Party or, if the registrant is under the age of 18, either or both of the Parties, will not receive any payment for, or have the right to approve, any such taking, ownership, use, retention, display, licensing, or assigning, and waive(s) any rights to privacy, to compensation, and to bring any action at law or in equity regarding same against any or all of TISC and the Organizers and their respective members, officers, directors, employees, independent contractors, agents, and volunteers.

CONSENT IS REQUIRED TO PARTICIPATE

Each Party understands that TISC and the Organizers would not permit either or both of the Parties to participate in any Activities unless this PHOTO AND MEDIA CONSENT which applies to all Activities whether occurring in the near or distant future, has been agreed to and that the terms of this document need not be brought to the attention of either of the Parties each time either or both of the Parties participate in an Activity in order for it to be effective.
